## Checklist for Addiction Counselor Reciprocity

To apply for reciprocity, you must meet the minimum requirements of certification that would otherwise be required of any applicant through the normal certification process with GPAICB.

Alcohol & Drug Counselor I (ADC-I) minimum of 4000 work hours (2 years working 40 hours per week) with Bachelor's degree. 300 hours of alcohol/drug/counseling education 15 hours in alcohol & drug specific coursework. Written examination.

Alcohol & Drug Counselor II (ADC-II) 300 hours of alcohol/drug/counseling education. 27 hours of alcohol & drug specific coursework. Written examination.

- With High School Diploma (or GED) 8,000 hours
- With Associate degree 6,000 hours
- With Bachelor's Degree: 4,000 hours
- With Master's Degree or above: 2,000 hours

Alcohol & Drug Counselor III (ADC-III) 300 hours of alcohol/drug/counseling education. 21 hours of higher-level alcohol & drug specific coursework. Written examination.

- With High School Diploma (or GED) 8,000 hours
- With Associate degree 6,000 hours
- With Bachelor's Degree: 4,000 hours
- With Master's Degree or above: 2,000 hours
